1. **Earnest Money Deposit (EMD):** INR [1 lakh] must be submitted via [DD/Bank Guarantee/Online Transfer]. EMD will be forfeited in case of withdrawal or failure to execute the agreement.
 2. **Security Deposit:** [5–10]% of the contract value will be retained as security deposit, refundable after successful completion and defect liability period.
 3. **Defect Liability Period:** 12 months from the date of completion.
 4. **Taxes and Duties:** All applicable taxes including GST shall be borne by the contractor.
 5. **Labour Laws:** Contractor must comply with all labour laws and regulations.
 6. **Safety Measures:** Contractor shall be responsible for the safety of workers and equipment at the site.
 7. **Work Quality:** Work must conform to the specifications laid down in the tender document and as per direction of the Engineer-in-Charge.
 8. **Delay Penalty:** A penalty of INR 10% per day (subject to max 25%) of total contract value will be levied for delay in work completion.
